How your Money is Managed

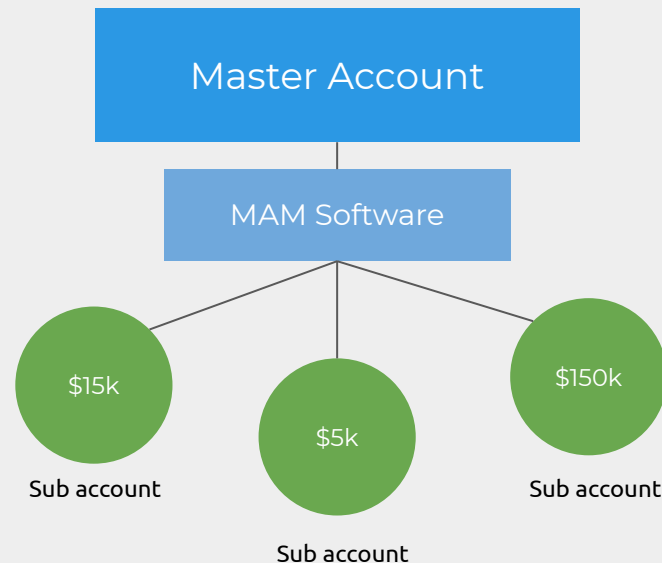
PlutusX utilizes a technology called “MAM” which stands for Multi Account Manager.

What is a “Managed Account” and how does it work?

A managed account allows you - the investor - to give us the control over what markets to trade in and how much of your investment to risk.

Your investment is deposited with a partnering broker we are affiliated with. It's held under your name in a segregated account, and it is not 'pooled' with other clients' investments. This gives you greater control to start and stop the trading, as you please.

When trades are placed, the software determines how much risk is involved and instantly calculates that percentage which is proportionate to your investment.



Benefits of a MAM Account

- Deposit and withdraw whenever you like
- Watch the progress of your investment in real time
- Ability to gain access to aggressive returns
- Investment is not pooled with other investors
- Lower minimum investment requirements
- No annual management fee
- No onboarding fees
- No maintenance fees
- Only pay when we perform

Risk Management

PlutusX deploys a highly efficient trading system that has been developed and refined over the last four years.

The strategy involves looking at the market from a different perspective than the most traditional retail traders which is giving us an edge in the market.

***RISK**

Baseline trades never exceed a risk of 1-2%.
Risk-to-reward ratio is always greater than 1:2.

***MAXIMUM DRAWDOWN**

Our aim is to stay below 1-2% per trade.

***MAXIMUM FLOATING LOSS**

We aim to stay below a 5% floating loss.

The Fee Structure

As compensation for the services, during each forthcoming monthly period, a fee will be withdrawn automatically from our regulated broker at the end of a 4-week cycle.

All profit and/or loss gets split into the ratio of 4:6 which means, the fund takes 40% and you take 60% of the profits generated.

We only earn on performance, meaning, if we don't perform, we don't get paid.

Fees are only deducted if your account is above the high water mark level.

The High Watermark model is arguably the fairest way for a trader and company to be remunerated for their work. It aligns interests with the investors.

Let's look at an example:

Bob invests \$10,000.

End of month 1 he makes 2.5% gain on his \$10,000.

His balance is: \$10,250.

Bobs high watermark was \$10,000. Therefore \$250 profit is eligible for a performance charge. PlutusX charges 40% of \$250 leaving him net after fees \$150.

\$10,150 is now his high watermark.

At the end of month 2, Bob experiences some market volatility and is down -1%. His investment is now worth \$~10,048.5.

There is no charge to Bobs account as he did not surpass his last known high watermark of \$10,150.
