What is Axi SELECT

The Axi Select programme provides an all-inclusive, structured pathway for traders to access funding and reach their trading potential. If you've got the skill, we'll back you with capital up to \$1 million USD.

What makes Axi Select unique? The programme is free to join, and you'll benefit from profit-sharing up to 90% of profits generated using Axi funds. You also get access to advanced trading tools, technical expertise and analysis, live educational content and a community network of professional traders.



The program is only open to trading accounts licensed under SVG regulation.

How do I join Axi Select?

Joining Axi Select is fast and straightforward. The programme is open for any individual with an Axi trading account.

If you're an existing Axi trading account holder with an Edge score of 50 or more on any of your Axi accounts and hold a minimum of \$500 USD in your Axi Select account (see more about the Edge score below), you can immediately progress to the Seed stage and receive up to \$5000 USD of funding from Axi.

For those who are new to Axi or do not have an Edge score of 50 yet, we'll facilitate the creation of your new trading account to kickstart your trading journey. Sign up on axi.com and follow the guided process to set up your account and enter the programme.

Definitions

Maximum Funding: The maximum amount of funding can be allocated in each stage

Profit Target (Allocation Account): The minimum profit level you must achieve to qualify for the next stage

Your Profit Share: The percentage of profits you are entitled to, based on the total profits earned on trades made using Axi funds. Your entitlement to profits only arises once transferred to your Axi Account

Minimum Equity: The minimum amount of equity needed to begin the stage. If you withdraw funds from your account, you must ensure you have this minimum equity to stay in the programme

Edge Score: The minimum Edge score you must achieve to qualify for each stage

Stage Duration (Min Days): The minimum number of days you must spend in the current stage before you can progress to the next stage

Trades Per Stage: The minimum number of total trades you must make within the current stage before you can progress to the next stage

Trades Per Month: The minimum number of trades you must make within each calendar month to remain in the current stage

Max Funding Multiplier: The maximum multiplier available in you Allocation Account for the current stage

Maximum Loss: The maximum percentage of losses you are allowed to sustain in the current stage. If your losses exceed the maximum, your account will be placed in Quarantine (see below)

Note: Quarantine does not apply to Seed stage. Seed stage can be restarted at any time without penalty, provided you meet the qualifying criteria.

What is the Edge score

The Edge score is a numerical representation that assesses your trading performance. It grants you a comprehensive and distinctive insight into your trading abilities, empowering you to flourish in your trading journey.

It is a weighted average of three measurable components of trading: **Skill, Risk, Consistency** and then multiplied by a discount factor depending on your **Experience**.

- **Skill** Measures your ability to generate profits while effectively managing drawdowns.
- **Risk** Evaluates your **proficiency** in managing risks effectively.
- **Consistency** Reflects your ability to achieve consistent gains, which showcases your understanding of market dynamics.
- **Experience** Assesses whether you meet minimum criteria for displaying credible trading experience.



How does Axi Select work?

Axi Select has been designed to provide a clear and structured pathway for traders to follow. Traders begin in the first stage, known as the Seed stage, and advance to higher stages as qualifying criteria are achieved. Each stage offers additional benefits, such as increased amounts of funding and higher profit-sharing percentages.

For a full list of rewards and qualifying criteria, please refer to the Axi Select Pathway table above.

Seed

To qualify for Seed the trader must have:

- Achieve a minimum Edge score of 50 by placing 20 closed trades
- Have a minimum equity of \$500 USD

Acceleration

Profit Share 50%

To qualify for Acceleration the trader must have:

- Complete Incubation stage
- Achieve a minimum Edge score of 70
- Have an equity of minimum \$2,000 USD

Pro 500

Profit Share 80%

To qualify for Pro 500 the trader must have:

- Complete Pro stage
- Achieve a minimum Edge score of 90
- Have an equity of minimum \$2,000 USD

Incubation

Profit Share 40%

To qualify for Incubation the trader must have:

- Complete Seed stage
- Achieve a minimum Edge score of 60
- Have a minimum equity \$1,000 USD

Pro

Profit Share 70%

To qualify for Pro the trader must have:

- Complete Acceleration stage
- Achieve a minimum Edge score of 90
- Have a minimum equity of \$2,000 USD

Pro M

Profit Share 90%

To qualify for Pro M the trader must have:

- Complete Pro 500 stage
- Achieve a minimum Edge score of 90
- Have a minimum equity of \$4,000 USD

Trading Room

The Axi Select Trading Room welcomes Axi Select users who have reached the Seed stage, providing a vibrant community of traders to share ideas, strategies, and insights. Access a wealth of knowledge through live educational videos and market analysis from experienced traders, fostering mutual growth and learning. The ability to interact with pro traders and receive regular market analysis empowers users to elevate their trading skills.

Quarantine

If a trader exceeds the maximum allowable losses in their Allocation Account, the account will be moved into quarantine. When entering a quarantine period, all open positions in the Allocation Account will be closed, no further funding allocations will be made, and use of the Allocation Account will be paused until quarantine has been completed.

A quarantine period is scheduled to end two weeks from the date the account was first placed in quarantine, provided the account meets the stage qualifying criteria. If, at the time the quarantine period is scheduled to end, the account equity and/or Edge score are below the required level, the trader will not be able to commence the stage or use the Allocation Account until the requirements are met.

Quarantine periods

- **First quarantine:** You will be invited back to the previous stage two weeks from the date the account was placed in quarantine, provided qualifying criteria have been met.
- **Second quarantine:** You will be invited back to the previous stage two weeks from the date the account was placed in quarantine, provided qualifying criteria have been met.
- **Third quarantine:** You will be invited to rejoin the programme at Seed stage, provided qualifying criteria have been met.

Quarantine does not apply to the Seed stage.

Once you reach the Pro stage, should you drop to quarantine you'll be invited to return to the Pro stage again (provided this is not your 3rd drop to quarantine).



What else do I need to know?

Deposits

- Depositing additional funds during a stage will not result in a corresponding increase in the Allocation Account funding.

For example, if a trader is at the Acceleration stage with \$2,000 USD in their Axi account, a x25 multiplier, and an Allocation Account of \$50,000 USD, even if they deposit an additional \$2,000 USD aiming for a maximum Allocation of \$100,000 USD, their credit allocation will not increase. It remains at the original \$50,000 USD.

Withdrawals

- If a trader initiates a withdrawal, the Allocation Account is reduced immediately by the withdrawal amount multiplied by the multiplier amount. Open positions are not automatically closed. If, however, after the withdrawal, the trader reaches Maximum Drawdown in their Allocation Account, they may enter quarantine status.
- It is the trader's responsibility to ensure they do not withdraw below the required amount. If they do, they will drop to quarantine.
- Withdrawal at any point during the month will result in the trader forfeiting any profit gained during that period. The Allocation Account will reset, and the multiplier will be recalculated based on the current funds in the Axi Select account and newly reset multiplier.
- To avoid any penalties, traders should withdraw once Performance Fees (PFs) have been paid out and before opening the first position in the new month. Once PFs are paid out, the trader can choose to withdraw and consequently set the multiplier for the month before placing a trade. Once a trade has been placed, the period will be deemed to have commenced, and the multiplier will be set.
- Example 1: If PFs were paid out on the 1st of August and there are no trades open by the 15th, and the trader requests a withdrawal, their Allocation and Multiplier are adjusted. Once a trade is placed, the multiplier will be determined, and any withdrawals made afterward is considered a mid-month withdrawal.
- Example 2, If PFs were paid out on the 1st of August, and the trader opens a position on the 2nd, then requests a withdrawal, their Allocation and Multiplier are adjusted. However, any profit share owed to the trader so far for this month will be forfeited.

Account maintenance requirements

- The minimum number of trades criteria is calculated only for full calendar months. Therefore, if you join partway through a month, you will not have to meet the criteria for that month. For example, if you enter a stage on the second day of the month, the minimum criteria of trades will not apply for that month.
- To continue participating in the Axi Select programme, traders need to ensure they meet the required minimum equity for each stage. The minimum equity ranges from \$500 USD at the Seed stage to \$4000 USD at the Pro M stage. Traders must also adhere to the minimum trade requirements and other conditions specified for each stage to avoid quarantine. Regular account reviews are conducted to ensure that they are due diligent.

Performance Fee (PF) payouts

For each stage of the programme, you may be entitled to receive a percentage of the profits gained, provided that:

The Allocation Account balance is higher than the original Axi funding amount at the end of the calendar month; and

There are no open positions in the Allocation Account.

If the above criteria are met, you will be entitled to receive a percentage of the profits, based on the difference between funds in the Allocation Account and the original Axi funding amount.

If you have any open positions at the end of the month, no payment will be made from the Allocation Account to the Axi account.

Performance fee payouts will be credited to your Axi Select account on the first day of the calendar month.

For example:

You are in the Incubation stage, starting with \$10,000 of Axi funds in your Allocation Account and, at the end of the month, your Allocation Account has an account balance of \$11,000. In that scenario, \$400 $[(\$11,000 - \$10,000) \times 40\%]$ will automatically be paid to your Axi Select account and your Allocation Account will be reset to \$10,000 on the first day of the month.

However, if you have open positions in your Allocation Account at the end of the month, no payment will be made, and your Allocation Account will remain unchanged. Only once the Allocation Account is flat at the end of the month will funds be transferred to your Axi account.
